B. GENERAL ELIGIBILITY

1. The candidate must be a domicile of the concerned Union Territory of Jammu & Kashmir having Valid ST Certificate/Valid supporting Document (for other eligible categories-to be attach with registration form), 50% seats to be filled from Block, 30% from District, 20% from UT.
2. The candidate must have passed or appearing in **Class V during Academic Session 2025-26** from a **Government / Government-aided / Government-recognized school**.
3. The candidate **must not have completed Class VI or higher class**.
4. The candidate must satisfy the **age criteria** mentioned as Sr. No. 02.
5. The candidate **should not have been debarred / rusticated** from any school earlier.

The registration form will be available **online** on the school website. Applicants are required to fill out the form and take a printout. The printed form must be duly **counter-signed by the concerned ZEO and signed by the Head of the Institution** before being submitted to the school.

- A copy of the Date of Birth Certificate**
- A copy of Category Certificate**
